Setting up your account is easy and newly established accounts are set up for purchasing immediately. Here are steps for setting up your account:

- Fill out and fax back the COMPLETED wholesale application (**Fax to 407-277-8525**)
- Fax us a copy of your business license and Tax exemption ID or resale certificate.

Wholesale Policies

Confidentiality – Any Wholesale account of Titan Motorsports agrees to the following terms of Confidentiality. Our clients and other parties with whom we do business entrust Titan Motorsports with important information relating to their businesses. It is our Policy that all information considered confidential will not be disclosed to external parties. Under no circumstances should your end customer be encouraged to contact Titan Motorsports directly for availability or backorder status. Furthermore it is our expectation that resellers do not contact our immediate vendors for any information regarding our account and orders.

Placing an order – All orders must be submitted in writing either via fax or by E-mail. Purchase orders are recommended. Email orders should be written in an individual message separate from other correspondence.

Canceled Order – All cancellations after 24 hours or withdrawal of funds from account will be subject to a 10% cancellation fee. All special order parts are subject to a 25% cancellation fee and/or any manufacturer return policy.

Returns & Exchanges – All Returns and Exchanges must be sent back with an appropriate RMA form. Titan Motorsports is not responsible for any returns without proper documentation. Titan Motorsports will exchange all incorrectly supplied items at our cost when the purchaser supplies all information regarding purchase in complete detail (including part number, item description and price). All problems must be noted within 7 day of receipt of parts. All other Returns are subject to a 25% restocking fee and/or any manufacturer return policy.

Payment – Acceptable payment methods include; Paypal, Wire Transfer, or Credit Card (All major cards accepted). Payment is required at the time of order, or at delivery in case of COD (Certified Funds) shipping. Any special orders, engine builds, or other orders at the sole discretion of Titan Motorsports may require a deposit to be placed before order will be fulfilled. **UNDER NO CIRCUMSTANCES WILL YOUR END CUSTOMER'S CREDIT CARD BE AN ACCEPTABLE METHOD OF PAYMENT.**

COD – We will ship COD to all established customers, per your request. COD fees are the responsibility of the recipient. All COD orders will be shipped noted for certified funds.

Shipping – All packages that are shipped from the Titan facility are shipped via Fedex Ground or Express 3 day unless otherwise instructed. We do also offer USPS and UPS to ship upon your request. On larger shipments we use Fedex Freight, DB Schenker, or Pilot.



Drop Shipping – Titan Motorsports, has one of the most competitive drop ship programs on the market. All Drop Ship orders that leave our facility are marked with your name and return address.

All tracking numbers from packages shipped from our facility will be passed along via e-mail. Drop ships from the manufacturer directly are available; Drop Ship fees may apply depending on the manufacturer.

Refused Shipments - Refused shipments will be subject to return shipping charge and restock fee.

Refusal of Service - Titan Motorsports reserves the right to cancel, refuse the sale, or delay any service to the reseller if they are unable to abide by the terms of Titan Motorsports. 1. Customers shall pay invoices according to terms printed on invoices in United States Dollars. Invoices not paid according to terms may be charged a late fee at the rate of five (5) percent per month (or the maximum amount allowed by law) on the unpaid balance. Titan Motorsports may, at its option, refuse to ship any product, require that orders be sent C.I.A. (cash-inadvance), or may terminate this agreement if Customer (1) is delinquent in payment hereunder, or (2) if Titan Motorsports deems Customer's current financial condition not creditworthy.
2. As security for the payment of the entire balance owed to Titan Motorsports, Titan Motorsports retains security interest in the goods sold to Customer. Titan Motorsports may, in the manner provided by law, retake the goods and, in addition hereto, pursue any other remedies provided by law. Customer agrees to execute all necessary financing security statements upon request of Titan Motorsports
3. Customer agrees to pay all costs of collection of any delinquent account including, but not limited to, attorney's fees, collection agency fees and court costs.
4. The terms of this agreement may be amended from time to time by written notice to Customer deposited in the United States mail and addressed to last known address. Titan Motorsports expressly reserves the right to change, without notice to Customer, the credit limit and/or credit terms available to Customer.
5. This agreement is entered into in the State of Florida. Customer hereby consents to the jurisdiction of the Florida courts of appropriate subject matter. The law of the State of Florida shall govern all disputes arising here from.
6. Customer represents and warrants that the information given by the Customer and relied upon by Titan Motorsports in this application is true and correct.
7. Titan Motorsports is authorized to investigate Customer's credit record and to report to responsible persons, and bureaus Customer's performance of this agreement. Customer agrees to provide further financial information and documentation as may be required from time to time by Titan Motorsports, as a condition for the continued extension of credit. Customer agrees to notify Titan Motorsports promptly of any changes in Customer's financial condition that may materially affect the Customer's stability. Customer agrees to notify Titan Motorsports in writing of any proposed changes in ownership, DBA/ Trade name, and locations as soon as practical, and in any event no later than ten (10) days prior to actual changes.
8. Until credit is approved, all purchases from Titan Motorsports will be on C.O.D. Cashier's Check basis unless otherwise approved in writing by Titan Motorsports.
9. Any sales, use, or similar such taxes assessed by the state, parish, or county of which Customer is resident shall be paid by Customer and payment of such shall be the sole responsibility of the Customer.
10. All Net term applications must be accompanied by Balance Sheet and Statement of Earnings dated within sixty (60) days of application date. For term purchases that exceed \$20,000 per month, audited financial statements are requested.
